<b>DESCRIPTION:</b>	This course is designed to provide educators with resource information and education materials that supplement across the curriculum in PreK-12. Develop understanding, thinking skills, creativity, and improve communication skills in the learning environment with students.</li><li>4. 4. **Post Class Assignments:** Participants must complete a course of independent work and an additional assigned project, to be submitted within two weeks of the conclusion of the institute.
